Articulation Agreement and Transfer Guide

Public health is the science and art of preventing illness and disease and promoting evidence-based health practices with the goal of improving the quality of life. It is concerned with threats to health based on population health analysis. The population in question can be as small as a handful of people, or as large as all the inhabitants of several continents. The dimensions of health can encompass a state of complete physical, mental and social well-being and not merely the absence of disease or infirmity, as defined by the United Nations World Health Organization (WHO). Public health incorporates the interdisciplinary approaches of epidemiology, biostatistics and a vast array of health services. A host of specialists including educators, journalists, researchers, administrators, environmentalists, demographers, social workers, laboratory scientists and more, work to protect the health of the public. Public health professionals serve local, national and international communities in settings such as environmental health, community health, behavioral health, health economics, public policy, insurance and occupational health. Public health is a very rewarding field offering great personal fulfillment in serving others.

According to Healthy People 2010 (a study of the U.S. Public Health Infrastructure), there is growing demand for public health professionals, which will exponentially increase with the advent of recently passed health care reform legislation known as the Affordable Care Act. Historically, public health education existed as a professional degree program with training at the graduate level only. In 2003, the Institute of Medicine (IOM) recommended that public health education be accessible to all undergraduates.

General Admission Criteria

Transfer Students to the University

2.00 GPA (on a 4.00 scale)

Transfer Students to the Program

Minimum GPA of 2.70 (on a 4.00 scale) or 3.00 (on a 4.00 scale) if applying for accelerated track.
 International applicants must submit a minimum paper or Internet TOEFL score of 550/80, respectively.

Advising Notes

It is recommended that potential applicants meet with an advisor to review the degree, course schedule, and have any questions answered prior to completing an application. Students who are completing the MTA may have different general education course requirements for the particular degree selected. Meeting with a Ferris advisor prior to the selection of general education or elective course work may reduce the chance of completing a course that will not apply toward the selected degree. Once admitted, students must continue to meet with an advisor as they work toward graduation.

Grand Rapids Community College courses that are listed above but are not part of the Pre-Public Health, A.A. degree requirements, may be completed at Grand Rapids Community College.

Transfer Student Orientation

All new students to Ferris State University are required to complete an orientation.

Reverse Transfer Agreement

Grand Rapids Community College and Ferris have entered into a partnership in order to work collaboratively and creatively to increase student completion of associate and bachelor degrees. The partners work together to provide a seamless transfer experience and increase student retention and completion at both Grand Rapids Community College and Ferris.

Michigan Transfer Agreement (MTA)

Ferris participates in the Michigan Transfer Agreement (MTA). This agreement will facilitate the transfer of general education requirements from one Michigan institution to another. Students may complete the MTA as part of a degree program or as a stand-alone package. The MTA consists of a minimum of 30 general education credit hours as identified by the college or university.

Students transferring to Ferris with the Michigan Transfer Agreement (MTA) and entering a degree program will have met a 30-hour block of lower-level general education courses. However, this does not exempt students from completing program specific prerequisites or higher-level general education course requirements. Students should contact their advisor regarding classes that meet the MTA.

Students must work with their Ferris advisor to declare a Minor or Concentration and for selection of Directed Electives.

Original Signed Articulation Agreement

This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

To the extent permitted by law, Ferris State University and Grand Rapids Community College agree to indemnify and hold one another harmless from any and all claims initiated by student participants, their parents, survivors, or agents, arising from any negligent acts or omission on the part of either institution or any of their employees.

Articulation Agreement

Effective Dates: June 15, 2020 - June 15, 2023

This Agreement shall commence as of June 15, 2020 and shall be for an initial term of three years. Minor updates to the agreement may be made during this time. This agreement may be renewed at the end of three years. Either party may terminate this agreement by providing the other party with written notice of the intent to terminate the agreement. The agreement shall terminate not less than one hundred eighty (180) days from the date of the termination notice, unless otherwise agreed in writing by both parties.
