PN 150 Synthesis of Practical Nursing Concepts

Credits: 4 Contact Hours: 8

Pre-Requisites: PN 131 and PN 140 (B- or higher in both)

Co-Requisites: None

This course is designed to further develop individual, health and illness, and professional nursing and health care concepts. Individual concepts include culture. Health and illness concepts include immunity, infection, pain, stress and coping, addiction, and interpersonal violence. Professional nursing and health care concepts include professional identity, clinical judgment, health promotion, communication, collaboration, safety and health care policy. Upon completion, students should be able to provide safe nursing care incorporating the concepts identified in this course.

Course Outcomes

- 1. Coordinated Care: The practical/vocational nursing student collaborates with health care team members to facilitate effective client care for a group of clients. (1.A)
- 2. Safety and Infection Control: The practical/vocational nursing student contributes to the protection of a group of clients and health care personnel from health and environmental hazards. (1.B)
- 3. Health Promotion and Maintenance: The practical/vocational nursing student *provides* nursing care for a group of clients that incorporate the knowledge of expected stages of growth and development, and prevention and/or early detection of health problems. (2)
- 4. Psychosocial Integrity: The practical/vocational nursing student *provides* care that assists with promotion and support of the emotional, mental and social well-being for a group of clients. (3)
- 5. Basic Care and Comfort: The practical/vocational nursing student *provides* comfort to a group of clients and assistance with the performance of activities of daily living. (4.A)
- 6. Pharmacological Therapies: The practical/vocational nursing student *provides* care related to the administration of medications to a group of clients and monitors the clients who are receiving parenteral therapies. (4.B)
- 7. Reduction of Risk Potential: The practical/vocational nursing student reduces the potential for a group of clients to develop complications or health problems related to treatments, procedures or existing conditions. (4.C)
- 8. Physiological Adaptation: The practical/vocational nursing student participates in *providing* care for a group of clients with acute, chronic or life-threatening physical health conditions. (4.D)
